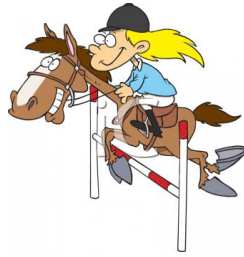

Please initial each statement:

- I consent to any hospital or medical care necessary for my child in the case of emergency medical treatment when parental/ guardians are unavailable for emergency consent. My child may be treated by any hospital or medical professional employed in any medical facility where he/she may be treated including all emergency treatments which in the judgment of said physicians may be considered necessary or advisable for my child's health and well being.
- I further understand this is a legal and binding consent for Hobby Horse Farms to use in the case of emergency. I have carefully read and understand this release from liability and consent for transportation and medical treatment and fully understand its contents. Being aware of its contents, I sign on my own free will.
- I understand that under Colorado Law, an equine professional is not liable for any injury to, or death of, a participant in equine activities resulting from the inherent risks of equine activities, pursuant to Section 13-21-119, Colorado Revised Statutes. I hereby indemnify and hold harmless Hobby Horse Farms, its managers, employees, volunteers and agents from any liability arising from accident, injury, theft or damage to me, my child, my representatives, my helpers, all equipment and all animals under my jurisdiction during this riding camp.
- I understand that whenever my child will be transported by a vehicle, that the driver of the vehicle will be (1) over the age of 18 years of age and a trusted employee/agent of Hobby Horse Farms, (2) possess a valid, unrestricted drivers license; (3) be an insured driver in the state of Colorado.
- I understand that my child will not be allowed to ride with any driver under the age of 18. Neither will my child be allowed to ride in a car driven by any student participant in Summer Riding Camp without the express written consent of a parent/guardian.
- I understand that this release applies to all official Hobby Horse Farm activities through July 20, 2012.

HOBBY HORSE FARMS POLICIES

Horse Assignments

Riders will be matched with a safe and appropriate horse on the first day of camp. Hobby Horse Farm instructors may change the horse assignment during the session. Suitable horses are available for beginners through to seasoned show riders.

Own Horses

Pending available space, campers may bring their own horses (with current health certificate) to ride in the camp as long as the horse is deemed appropriate and safe for the rider. If Hobby Horse Farms instructors consider the camper's own horse to be unsafe or insufficiently sound the camper will be assigned to a Hobby Horse Farm horse. Campers' own horses may trailer in daily or be boarded at Hobby Horse Farm at the current pro-rated rates.

Phone Calls

Cell phones will be off during hours of instruction and should be used for emergencies only. Campers may always be reached through Hobby Horse Farms phone at (303) 834-0176.

Gum

Chewing gum is a safety hazard while riding horses. No gum please.

Field Trips

A field trip is planned during each session to a rated horse show, off Hobby Horse Farm property.

Two week camp: \$700

\$600 Current HHF Students

First week only: \$400

WHAT TO BRING TO RIDING CAMP

Riding Clothes

- Hard Hat (*Hobby Horse has a limited number of loaners in a range of sizes*)
- Boot with hard heel
- Jodpurs, breeches, or jeans
- Safety vest (optional)
- Riding gloves (optional)
- Spurs (optional)

Additional Suggested Items

- Change of clothes - for warm weather (shorts, t-shirt, etc.) that can be worn in a barn environment.
- Change of shoes (eg: tennis shoes—no sandals, please)
- Swim Suit, towel, slip on sandals or water shoes
- Water Bottle
- Lip Balm
- Sunscreen
- Mosquito repellent

Camp hours will be from 9am – 4pm Monday – Friday. For the convenience of working parents, arrangements can be made for early arrival and late pick-up.
